Minutes - January Meeting by Mary Cottrell

The January BMW Club meeting was called to order by President Dave Pritchard. The Treasurer reported approximately \$15. in the treasury.

The activities report was given by Dave Cottrell. The events for January and February were announced (See Activities Report elsewhere). Dave announced that the Corvette Club had been granted exclusive use of Wickes parking lot after getting a use permit from the Virginia Beach City Council. It was suggested that perhaps Glynn Rogers of SEVSCO should attempt to go to city council to clear the SEVSCO clubs of the bad name they have received concerning autocrosses.

At the December SEVSCO meeting every—thing that was brought up for approval was passed. Our club needs to purchase the SCCA General Competition Rules. Ken Browning indicated that there is a need to clear up the question of fender flares in stock class.

Dave Cottrell is our Autocross Committee representative; Steve Sachs is the Committee Chairman. Ken will be our Rally Committee representative and Drew Jeffreys will be on the Bylaws Committee. Our club must submit our representatives' names and these can not be changed without advance notice to SEVSCO.

Dave Cottrell asked that the Treasurer put March 1 on our SEVSCO membership cards instead of Jan. 1. The merchants will honor the date put on the cards.

Dave Pritchard announced that our treasurer will collect dues of \$10. for our club. Jim Craig moved that we try to tie in with National BMWCCA in having them collect the combined dues as soon as they get organized to do so. Dave Cottrell seconded the motion and it was carried. We will colect at least until the end of March.

New members of BMWCCA that are in our area should receive information about our club from National. We need to recheck this information and/or update it.

Jim Rhyne asked about the trophies for Ken's rally. Jim also announced that the Champoinship Event results were scored wrong and hopefully will be corrected. Also he said that TSCC's protest concerning Bob Holland's car should be honored as there is now proof of the car not being street legal.

The parts person, Dave Cottrell, gave a short report of parts presently available. He reminded members of how the parts kitty should work. There was a discussion on driving lights and air horns. It was suggested that a questionaire be made up to find out what is needed by members for the parts department. Jin Rhyne and Dave Cottrell told the membership of parts they have available.

There will be a driver's school by TSCC on February 23rd.

TACH's Twice Around by Ken Browning

On Feb. 17 TACH hosted their "Twice Around" autocross. The whole idea of this event was to be able to come back to the same course two weeks later after making different changes in tire pressures or other suspension changes and be able to see what effect they would have.

I had gotten a set of old R-4 race tires from Jim Rhyne on Saturday to run the event on. I had only driven on race tires once before and they were a different compound. This was going to be a whole new bag. I was really looking forward to this event.

On Sunday, as Nature would have it, it rained. To start with, I didn't know what kind of tire pressures to use in the dry much less in the wet. On my first run the car jumped out of 2nd in one of the turns and I got a pylon to boot. But on the second run all I got was one pylon when I went across the finish line — drat it!

The only other car in class (C/M) was Larry Edwards 510 Datsun. Larry couldn't run because of a cut hand he had gotten

while trying to load his car about two weeks ago - Larry, you dummy!

So his wife, Dee, and Larry's number one mechanic, Karl Hawkins were driving the car. On Karl's first run he did the best 360 I have ever seen. Yea Karl! On his second run he clipped a few pylons.

Unless it rains again on the next half of this event (March 2), the whole idea behind it will be lost. TACH put all the space in the new lot to good use and the event was very fast, which I really liked.

I am not sure about this but rumor has it that Jeff Guerdat's Fiat 850 beat Jim Rhyne's Super 7 for stock FTD.

SEVCSO = Confusion by Ken Browning

At the start of 1975 my BMW was in E/S as it had been for the past three years. But at the Feb. SEVSCO meeting the Board made several clarifications, one being the flared fender rule (or lack of one-ed.).

When our present autocross code was conceived the autocross committee allowed an $1\frac{1}{2}$ " increase in rim width (in stock class) because most people put a set of mags on a car as a dress up item and most are not of a stock offset or width. But some cars like the BMW's, Sprites, and Fiat 850 don't have enough room under the fenderwells to allow an increase of $1\frac{1}{2}$ ". At this meeting it was agreed to allow fender flares. But as an oversight this was left out of the printed code.

Now all cars with flared fenders will have to run in the modified classing system.

If the SEVSCO Board wants to go strictly by the rules as the code states: "All cars must be as produced", there arn't more than 10 cars running as produced. Every car that has a smaller diameter steering wheel, spoiler, or tach that wasn't produced on the car has to run in a mod. class. This isn't the intention of the autocross committee or the code.

I think that this problem can be taken care of if the Board will just be open minded enough to make the needed changes.

TECH TIPS

On Thermostats

Somewhere around the first part of Jan. I noticed a sharp rise in my BMW's water temperature. Since my 2002 has gone some 43,000 miles without mishap I suspected the thermostat. I parted with the needed \$15.58 to purchase one from Smith Corner in Portsmouth. That price was with a 10% discount. I planned to install it at the tech session at Dave Pritchard's house, but the car refused to overheat that day. So I enjoyed myself, had a few beers, and changed a as line. I changed the thermostat the next day and to my horror the situation remained the same. At that point my imagination took over, bad water pump, blocked radiator, blown head gasket, and so on.

I talked with several of our fine, upstanding club members and listened to what they had to say. I had the radiator checked; no problem. No water in the oil-good! After reading the article in the Feb. das Kummet about the Standard-Thompson #140, I decided to try it. Dave Cottrell ordered one from Flower's Auto in Portsmouth and I picked it up and put it on my car.

All is calm and serene once more. I got back the money from Smith Corner for the defective new thermostat. The one distributed by Standard-Thompson is made by Behr in West Germany. The cost was \$10.70 as opposed to the discounted \$15.58 at the dealer. Think about it and keep it in mind for the future.

If your gas cap sticks and has a rubber gasket, put a liberal coating of "Sil-Glyde" made by American Grease Stick Co. on it. While this is not a permanent solution, it will last for several weeks.

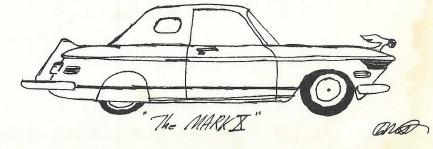
Fram Wiper Blade Refills - Revisited by Dave Cottrell

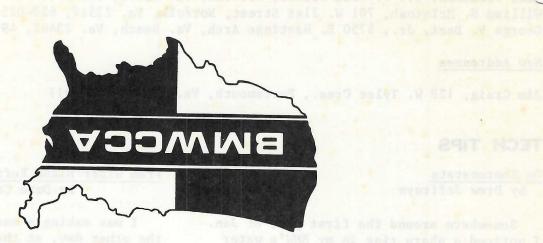
